# NWAGA Point Evaluation System Determining: NWAGA Player of the Year 

The purpose of Nebraska Women's Amateur Golf Association's (NWAGA) point evaluation system is to establish objective criteria by which the NWAGA Board of Directors can judge the performance of NWAGA members who participate in NWAGA tournaments with gross divisions and Nebraska Golf Association (NebGolf) Women's Championships with gross divisions. A player must have participated in at least one NWAGA tournament to be eligible for consideration in the point standings.

In case of ties, each player receives the sum of tied points divided by the number of positions.

## Tournament Participation Limit

In order to prevent an unfair advantage of one player over others, simply by playing in more tournaments, each player will only be allocated points based on the player's best four tournament finishes.

The NWAGA Board of Directors will use the point evaluation system as a guide and not as an absolute measure of a player's performance. Other criteria to be used include but are not limited to: a player's Handicap Index, compliance with the Rules of Golf and Rules of Amateur Status, the USGA's policy on gambling, and a player's integrity and conduct both on and off the golf course.
